● Application:

Recommended for cleaning, disinfection and deodorization of floors and surfaces in communities: schools, buildings, retirement homes, hotels, restaurants, etc.

Without rinsing*, leaves no traces. Low foaming, it can be used in an auto-washer and in a dilution plant. Effective on enveloped viruses such as Coronavirus and its variants, H1N1 etc.

● Directions for use:

For a disinfectant action: dilution from 0.5% in water.

For a scented wash: 20 to 50mL depending on the desired persistence.
