Application:

Ready-to-use disinfectant cleaner with bactericidal, yeasticidal and virucidal activity, only against enveloped viruses. For hard non-porous surfaces in contact or not with food or animal feed in the domestic, institutional (excluding the medical sector) and industrial sectors.

Cleans and disinfects in a single application.

No alcohol, quaternary ammoniums, aldehydes or chlorinated derivatives.

COMPOSITION:

Active biocidal substance TP2/4: Lactic acid disinfectant (CAS: 50-21-5): 0.42g/100g; anionic surfactants, <5% nonionic surfactants, . Also contains: water.

99.8% of the total ingredients are of natural origin.

Directions for use:

Apply the product by spray (approximately 19 sprays/m²), making sure to evenly wet the surface. If necessary, use a brush to distribute the product. Leave on for at least 5 minutes. Scrub and brush after disinfection to remove dirt if necessary. Wipe or rinse to remove excess liquid. Apply once. Disinfect surfaces as often as required by current hygiene protocol.
